These duties include respecting the Constitution, cherishing its ideals, promoting the spirit of fraternity, and safeguarding public property and natural resources, fostering a harmonious balance between rights and responsibilities for a thriving democratic society.

Additionally, it seeks to encourage public discourse on the relevance of constitutional values in contemporary times, fostering a deeper appreciation for the document that serves as the cornerstone of India's democratic framework. Through various events, discussions, and educational initiatives, the celebration intends to reinforce the commitment to upholding and

safeguarding the Constitution's ideals and ethos.
