School of law is hosting the first ever Crime scene investigation competition with an objective of inculcating practical based learning from the students. Crime Scene where any offence is committed is the subject matter of any criminal proceeding and thus this competition is arranged for our students to learn more about the circumstances surrounding a crime by using physical evidence from the crime scene and use of inductive and deductive reasoning to analyse the circumstantial evidences and facts.

It is multidisciplinary competition and involves a systematic search of the crime scene with meticulous observation and documentation of the scene; photography and sketching; the identification, processing, and analysis of physical evidence such as footprints, blood, hair, fibres, biological fluids, other evidence; and perhaps the most important, the application of observational skills and reasoning capacity by the participants.

Outline of the Program:

Crime scene investigation competition is an activity for students wherein their task is to discover additional information about the circumstances leading up to a crime utilizing physical evidence from the crime scene and inductive and deductive analysis. It is multidisciplinary and entails a methodical investigation of the crime scene, including careful observation and documentation of the scene; photography and sketching; the identification, processing, and collection of physical evidence, such as fingerprints, footprints, hair, fibers, biological fluids, and materials for DNA analysis; and, perhaps most importantly, the participants' use of their own observational skills and capacity for reasoning.



DAY 1

26.04.2024

1. The day started with registration of teams. Ms. Bonny Ghosh and her team was in charge of registration. Ten teams registered from First, Second, Third and Fourth years of BA/BBALLB(H) Courses.

2. By 11.00 am the Crime Scene was set for investigation and Hon'ble Vice Chancellor along with Hon'ble Deputy Registrar inaugurated the event. After which a formal address was given by the Hon'ble Vice Chancellor along with Hon'ble Deputy Registrar encouraging the teams participating and enlightening the spirit of the organizing team.

4. Dr. Keval Ukey gave a brief orientation and discussed the facts of the case to be investigated.



Students in the sciences and forensics were tasked with observing the crime scene, directing the teams, and offering them forensic assistance.













6. The Crime scene was open for public view afterwards.

DAY 2
