Event Report

Event Name: Visit to District Legal Aid Service (DLSA) and Interaction with Judges

Date of the Event: 23rd October 2024

Objective of the Program:

The primary objective of the visit organized by the School of Law at Sandip University to the District Legal Services Authority (DLSA) on October 23, 2024, was to enhance students' practical knowledge of the legal system and familiarize them with the functioning of DLSA. The program aimed to provide law students with first-hand experience in observing legal proceedings, interacting with judges, and gaining a deeper understanding of the application of law, specifically focusing on civil and criminal matters. The visit sought to bridge theoretical knowledge with practical insights through interaction with legal professionals and exposure to real-world legal scenarios.

Outline of the Program:

The day's program featured a series of lectures by prominent legal experts. Secretary Shri M. V. Borade introduced the students to the role and functions of DLSA, emphasizing its importance in providing legal aid and promoting justice for underprivileged sections of society. Adv. Shaikh offered a comparative analysis of recent amendments in criminal laws, highlighting key changes and their impact on legal practice. Adv. Shri V. Nasshikkar discussed the Pre-conception and Prenatal Diagnostic Techniques (Prohibition of Sex Selection) Act (PIMA) within the context of commercial disputes, adding a commercial law perspective. Assistant Professor Paresh Shahane's lecture addressed cybersecurity concerns, underscoring the growing importance of digital law in

the modern legal landscape. The students also observed court proceedings and interacted with Hon'ble Judges Umeshchandra More and Babasaheb Wagh, gaining practical insights into the judicial process.

Participants:

Over 60 students, accompanied by faculty members and the Dean of the School of Law, participated in the visit.

Outcomes:

The visit proved to be highly beneficial for the law students, offering them a unique opportunity to witness legal processes in action. Through their interactions with the judges and legal professionals, the students gained a better understanding of the practical challenges and nuances of civil and criminal cases. The lectures provided valuable knowledge on the changing dimensions of law, from criminal amendments to cybersecurity and commercial disputes, broadening the students' perspectives. Moreover, observing live court sessions helped students connect their theoretical learning with real-world judicial practices, enhancing their legal acumen and preparing them for future roles in the legal profession.
