Event Outline, Objective and Outcome of the event: The competition includes a rigorous training programme to provide valuable training, experience, and feedback to all participants. Teams then collaborate to investigate and draught a brief for a case based on current legal concerns. After submitting their brief, competitors undergo extra oral advocacy training from experienced advocates. Once the competition begins, each participant has the opportunity to argue their case before a panel of prominent members of the bench and bar. Participants must qualify via four rounds to reach the finals: preliminary rounds I and II, quarter finals, and semifinals.

Outline of Program: The Beginning of New Chapter for School of Law!

The Sandip University School of Law hosted the "1st Shri Nityanand Jha National Moot Court Competition 2022," which conducted from October 13th to October 15th. Students from all across India took part in the competition. A total of 30 teams registered for this competition. The event kicked off on October

13th at 9:00 A.M. with the inauguration ceremony. Hon'ble Inspector General of Police B.G. Shekhar Patil, Chief Guest, and Adv. Nitin Baburao Thakare, President and General Secretary of the Nashik Bar Association, M.V.P., guest of honor applauded the efforts of the students and the faculties who pro-actively and enthusiastically organized the event. The event followed immediately by the preliminary rounds of the competition. The researcher's test took place on October 13th 2022, marking the formal start of the competition. 8 out of 30 teams qualified for the Quarter and Semi-Finals, which was held on 14th October.

The Quarter Final Round began at 10:00 a.m. on day 2 of the competition, October 14th. and concluded at 1:00 p.m. Four of the eight teams made it to the semi-finals. The Semi-Final round began shortly after the drawing of lots and the exchanging of memorials. The two finalist team were announced by the end of the day.

The final round of the moot court competition began at 10:00am, on 15th October and the finalists then took their places in the courtroom. Chief Guest Hon'ble Justice Aniruddha P. Mayee Judge, of Gujarat High Court and Dr. Harunrashid Kadri Principal of N.B. Thakur Law College were invited as a judge and the proceedings began. The finalists argued their cases before the judges and the audience. The competition was very intense, as both sides fought hard to win. On completion of the final round the participant teams, students, Advocates, Judges, academicians headed seminar hall for the valedictory event. The event was graced by: Hon'ble Chairman Dr. Sandip N. Jha, Vice Chancellor Dr. Rajendra Sinha, Registrar Dr. Anil Maheshwari, Associate Dean Dr. Bhavana Kadu, OSD Sir Vivek Nikam.

After deliberation, the judges declared Swati Jhajhria, Deepsea Chakarborthy, Mohit Yadav of Army Law College, Pune as the competition's winner awarding them a cash reward of 21,000/- and a Law Finder Subscription worth 21,000/. Ridhima Jain, Ujjuval Garg, and Swati Jha of Lloyd Law College, UP, are the runners-up, receiving a cash prize of 15,000/- and a Law Finder Subscription worth 21,000/-. Shejal Kanwar of RNB Global University Bikaner won the Best Speaker award of Rs. 5,000/-, while Bhupendrsa S. won the Best Researcher award of Rs. 5,000/-. Mounish Chanukya, Ishan Khisti, and Mohak Kasat of the Symbiosis Law School, Nagpur won the Best Memorial award.



















