- Incorporating legal precedents to support the appeal.
- Workshop on drafting an appeal against a criminal conviction.

### **Revision Applications**

- The concept of revision in criminal law.
- Drafting a revision application to the higher court.
- Highlighting errors and illegalities in the lower court's decision.
- Effective use of case laws and precedents.
- Mock revision application exercise.


The speaker held a comprehensive workshop on mastering criminal drafting provides participants with the knowledge and skills required to excel in the field of criminal law. He focused on complaint drafting, criminal miscellaneous petitions, bail applications, memoranda of appeal, and revision applications, participants will gain a deep understanding of the legal process and improve their ability to advocate effectively in criminal cases.


