- ✓ It must content Name of the Court, date, time and Purpose.

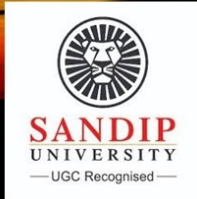

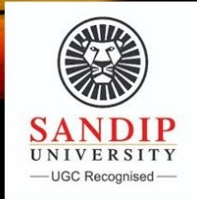
