Subject: **Proposal for 12-B status – Regarding.**

Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC Expert Committee on **19-20th November, 2021** to consider the proposal. The Report of the Expert Committee alongwith the compliance submitted by the University was placed before the Standing Committee of UGC members for consideration. The Committee recommended as under:-

“The Committee considered the report of the UGC’s Expert Committee along with the compliance submitted by the University.

The Committee decided to recommend approval of 12 B status to Sandip University, Trimbak Road, Mahiravani, Nashik - 422213, Maharashtra (Private University) subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.

The University is advised to participate in NIRF ranking and get NAAC accreditation at the earliest and to ensure that the faculty sanctioned and in position should be as per concerned statutory council(s)/ UGC norms in all the Departments.”

The above recommendations of the Committee along with the Report of the UGC Expert Committee were placed before the Commission in its 555th meeting {item No.1.02(a)(v)} held on 12th February, 2022. The Commission has ratified the recommendations of the Committee.

The name of University has been included in the list of universities under Section 12(B) of the UGC Act, 1956.
